Glenoaks Blvd, El Tarasco restaurant Conditional Use Permit full alcoholic sales for on-site consumption in an existing restaurant with occasional "Live"? Approval of plans to allow the continue sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with an existing 23,107 square-foot restaurant with 78 seats to operate 8am to 11pm M-Thursday and 7am to 12am Friday and Saturday in the C2-1 zone. Applicant representative Anibal Guerrero listed.

Glenoaks Blvd, Allco Renewable Energy Solar Facility – Notice was received early December 2015 of an application for a 1 megawatt (AC) Ground-Mounted, Fixed-Tilt, solar-photovoltaic electricity generation facility. This application was subsequently canceled and Allco filed an appeal against the City of Los Angeles Planning Department for adding solar electrical generating facilities as projects that require a Zone Variance and Conditional Use Permit. Allco argues that solar electrical generating facilities should be by-right meaning no public review or discretionary approvals required for permitting. DIR-2016-1806-BSA and ENV-2015-4350-EAF
