Manuel is the architect - resident of Sylmar

Meta's mission is about providing affordable housing to individuals.

All projects come with services

rent burdened - more than 1/3 of their income to rent Ara:

56 total units: 11 Units for low income - 44 for homeless

53 studios, 2 one-bedrooms, 1 one-bedroom for manager

Property Management: John Stewart Company

Daniel: La Family Housing - Support services for the site (been around for 35 years)

Funding from various sources: Prop H, Developers, etc.

Ara: Approx cost of building project - are currently picking design (over \$20M for building) Hoping to start construction beginning of 2020

Manuel: Y & M Architects: Dedicated to do only affordable housing.

4 story building - 3 stories apartments over the parking structure and rec spaces and supportive offices

Target population: 44 single adults. Could be 2 families in the 2 one-bedrooms.

Reduced parking - 30% (1 parking space for every 3 units)

Some tenants may have some SSI, but no major income.

Units will be furnished.

Driveway will be gated.

Patty Hug suggests softer, rounder edges on roofline.

Single point of entry - entrance either through parking or front lobby.

Anti-graffiti coating on ground level or keep up maintenance by painting.

Looking to be a buy-right project.
