San Fernando Road City-owned property considered for development of affordable housing by Los Angeles Neighborhood Housing Services, Inc. a (501c3) corporation located at 3926 Wilshire Blvd. Suite 200, Los Angeles. Jesse Ibarra, Assistant Vice President & Director of Business Development. Plan is a Small Lot Subdivision for 54- For Sale Units some at market others at 80-120% of medium income. Jesse stated they own the lot at 12534 SFR and have cleared the existing home and property is zoned RD3-1XL-CPIO.

NHS is the largest, non-profit, affordable homeownership provider in Southern California. For over 30 years, NHS has helped families in communities throughout Los Angeles County to become more financially informed, achieve and sustain affordable homeownership and to stabilize and revitalize neighborhoods. Since 1984, NHS has developed and rehabilitated over 21,260 housing and commercial units, placed 4.4 million families on the road to homeownership, created 225 block clubs, employed 232 neighborhood youth, and invested more than \$5.35 billion back into some of Los Angeles County's toughest neighborhoods.

Women Organizing Resources Knowledge and Services (WORKS), through a competitive Request for Proposals (RFP) or Request for Qualification/Proposals (RFP/Q) was identified as the party selected to negotiate with the City the development of the site. File No. 18-0261
