 - c. Foothill Trunk Line Project Update: Christina Holland, "As we prepare to put a pause on the project and turn the Hubbard work area over to City of San Fernando's reservoir replacement crew. We expect to be fully out of the area by Thursday, April 27th. Our crews will be moving to the next work area near the intersection of Foothill and Maclay. When I have this schedule, I'll share it with you."

Since the crew began work earlier this year, they've made tremendous progress – even with all our weather challenges. By the time we vacate the Hubbard area, we expect to have installed over 1,300 feet of 12" and 16" mainline pipe on Foothill Blvd (between Sayre St and Gridley St).
