1. **Call to Order**, Advisory Board Roll Call, Code of Civility
2. **Opening Remarks:** (Board Chair & Executive Director) [The ***After the Fire*** Conference Update]
3. **Insurance Update from the California Department of Insurance:** Don't miss this opportunity to hear from the California Department of Insurance as California moves into the fall. Not only will wildfire issues be covered, but also flood insurance, as El Nino is proving to be a significant threat - not to mention the risk of flooding following a wildfire incident.
4. **Community Update on the '26 Getty Fire:** Following a number of community members concerns regarding evacuation management (there was no evacuation) and communications related to the September 9, 2026 "Getty" fire, we developed a snap-survey. We'll share results - interesting data!
5. **Zone 0:** We'll have a report on the withdrawal of the Zone 0 legislation from the California Office of Administrative Law. While this is supposedly a "technical" update to make things a bit more specific for the OAL, the withdrawal itself is newsworthy. What happens next?
