from Outreach for the Make Your Horse Count Event tentatively scheduled for October 21st. The Sylmar NC would be the main organizer of this event. The event will take place in Stetson Ranch Park located at 15455 Glenoaks Blvd. The purpose of this event is to highlight the equestrian presence in Sylmar and raise awareness of licensing horse. The Outreach objective for this event will be to add 500 new stakeholders to our various communication platforms (Facebook, Email Database)

Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a stakeholder may become the subject of a future Board meeting.

Any Committee action may be reconsidered following the Meeting when the original action occurred. A Committee Member makes a Motion for Reconsideration and if approved another vote on the issue takes place based on the reasoning for the reconsideration. The Committee Member must have been on the prevailing side of the action/issue.
